Subject: Last opportunity for leftover trainee's data migration and trainee verification for the trainees admitted in CTS for the session 2024 to DGT portal (SIDH) -Regarding.

Sir/Madam,

The Directorate General of Training (DGT) in the Ministry of Skill Development and Entrepreneurship coordinates national vocational training programs in Industrial Training Institutes (ITIs). The DGT sets standards and conducts trade testing, while the day-to-day administration of ITIs is managed by State Governments and Union Territory Administrations.

2. The DGT releases a Training Calendar for each session to all State/UT directorates to conduct the CTS admission process in government and private ITIs according to the schedule provided. The deadline for admission in all government and private ITIs nationwide is set for October 30, 2024.

3. In this context, State/UT Directorates and NSTIs have uploaded data for approximately 14.19 lakh trainees to date, out of which around 12 lakh trainees have completed verification. According to information from State/UT directorates, some trainee records are pending upload for various reasons, and some trainees have not completed verification. After careful review, the competent authority has decided to provide a final opportunity for data migration of the remaining trainees and trainee verification for the session 2024 is outlined below:

Data Migration Schedule: Six Month (Batch-I, II), One-year and Two-Year Trades: Session:2024.

It is the responsibility of the State/UT Directorate and ITI to ensure that all trainees complete the Trainee Verification process according to the schedule. No further extension of the cut-off date is possible due to upcoming examination activities. A unique PRN (Permanent Registration Number) is generated only after the trainee completes this step, confirming the trainee's admission with DGT on the portal. Remaining trainees will be considered inactive, and no further activity is allowed for them on the DGT portal. The FAQ document for Trainee Verification is attached in Annexure I for reference.

Annexure-I FAQ for CTS Trainee Verification 2024
CTS Trainee Verification Process on SIDH portal (Session 2024)

Trainee Verification is three-step process

- 1. Mobile Verification:** The trainee's registered mobile number will be authenticated through an OTP received on their mobile. (This number does not need to be registered with Aadhaar)
- 2. Photo Capture:** The ITI will capture the trainee's photo at this step, which will be used for printing on the hall ticket, certificate, etc.
- 3. KYC:** Trainee identity verification will be conducted through this step using Aadhaar or non-Aadhaar methods.

Frequently asked Questions (FAQs)

Query	Description	Reason	Solution
Query -1	ITI Login: User type not supported or invalid user.	ITI Mistake: ITI is trying to login with un-registered mobile number.	Please check your registered mobile number in below link and login with correct/registered mobile number. http://164.100.117.165/itiadmission/
Query -2	ITI Login: While ITI login with registered mobile number, system is giving error <i>"Please complete trainee verification by visiting your ITI and login here after PRN generation"</i>	ITI Mistake: ITI has used its registered mobile number for trainee admission and uploaded trainee data for the session 2024.	ITI needs to update the trainee's mobile number to a new one by contacting the respective state directorate. The option to change the trainee's mobile number is available in the respective state login. After the trainee's mobile number has been updated, ITIs can log in and proceed with the trainee verification process.

Query -6	Aadhaar Mobile issue: Aadhar linked mobile is not available with the trainee	Trainee lost his/her Aadhaar registered mobile number.	Trainee can update new mobile number in Aadhaar and proceed for eKYC.
Query -7	Trainee Mobile issue: Trainee Mobile number is not accessible.	Trainee mistake: DGT has given clear instructions to preserve mobile and email id till certificate generation.	The respective state directorates have the functionality to change a trainee's mobile number. Please note that the trainee's mobile number cannot be changed once eKYC is completed.
Query -8	Aadhar OTP issue: Aadhar OTP is not received by trainee.	Aadhar OTP is not received/delayed: May be network issue. Trainee may be checking for OTP in non-registered mobile.	Trainee may try after some time or in a network area. Please check on Aadhaar registered mobile number.
Query -9	Aadhar number wrongly entered: Unable to match uploaded Aadhar number and entered Aadhaar number (in case of Aadhaar trainees)	Mis-entry of Trainee Aadhaar number by ITI/State: During the data migration process, trainee Aadhaar number might be wrongly entered.
